Reopening of Notice of Public Exam for the admission to the doctoral research courses of the 33rd cycle issued with Chancellor's Decree n. 1314 dated 14.04.2017 supplemented by Chancellor's Decree n. 1702 dated 15.05.2017.

Last date for application submission: 19 September 2017.

THE CHANCELLOR

Having taken the following into account:

- Ministerial Decree No. 45 of 08.02.2013, published in the *Gazzetta Ufficiale* (Italian Official Gazette, from now on O.G.) O.G. No. 104 of 06.05.2013 with which the Rules and Regulations relative to the Ph.D. courses were issued and which determine the general criteria and the requirements for the setting up of the Ph.D. courses and the suitability of the venues, as well as the criteria for the establishment of the Ph.D. courses by the authorized institutes;
- The Chancellor's Decree No. 347 of 05.06.2013 containing the University's Rules and Regulations for the Ph.D. Courses and subsequent modifications and integrations;
- Chancellor's Decree n. 1314 dated 14.04.2017 supplemented by Chancellor's Decree n. 1702 dated 15.05.2017 which announces a public exam for admission to the Research Doctorate courses – 33rd cycle;
- The Decree dated 05.09.2017 issued by the Coordinator of the doctoral research course in Computer Science and Systems Engineering, which requires the urgent reopening of the Notice for the admission to the doctoral research course in Computer Science and Systems Engineering- Curriculum Secure and Reliable Systems (2 places with 2 grants funded by the Bruno Kessler Foundation – FBK);
- The selection for the admission to the doctoral research course in Computer Science and Systems Engineering- Curriculum Secure and Reliable Systems, approved by Chancellor's Decree n. 2911 of 4 august 2017, was completed without any successful candidates;
- Chancellor's Decree No. 3055 dated 25.08.2017 concerning the displacement of two grants from the doctoral research course in Computer Science and Systems Engineering- Curriculum Secure and Reliable Systems to the Curriculum Computer Science;
- There are still 2 unallocated grants funded by the Bruno Kessler Foundation – FBK;
- Coordinator's reformulation of research themes, which will allow further candidates to take part in research activities with proper preparation to research activities ;
- Exams's timetable proposed by the Coordinator;
- According to Ministerial Decree No. 45/2013, public-selection procedures for the admission to the Research Doctorate courses have to complete within 30th September;
- Considered appropriate, given the interest of the University of Genoa to increase participation to the admission to the Research Doctorate, to accept the request of the Coordinator of the doctoral research course in Computer Science and Systems Engineering;

HEREBY DECREES

Art.1

The terms for the presentation of applications for submission to the public exam for the admission to the doctoral research course in Computer Science and Systems Engineering - Curriculum Secure and Reliable Systems –33rd Cycle are re opened.

Applications for the selection procedure shall be submitted by means of the online procedure available at the address <http://servizionline.unige.it/studenti/post-laurea/dottorato>, by 12 noon (italian time) of 19 september 2017 (the expiry date of the public notice).

Art.2

The updated details as per the previous art. 1 and particularly available places, the timetable, contents and testing procedures and the provided research themes are noted in the document “Annex A- Reopening” which is an integral part of the current decree.

Art. 3

. The final lists shall be announced on 2 october 2017, and will appear solely on:

- The noticeboard of the relevant research Departments/specific areas for the research courses;
- The noticeboard of the University;
- On the Internet addresses <http://www.studenti.unige.it/postlaurea/dottorati/>.

No information whatsoever shall be posted to candidates' domicile.

Art. 4

Candidates who have been admitted to the doctoral courses shall submit their enrolment applications by means of the relevant procedure, the details of which shall be published by the Area didattica e studenti (Didactic and student area), Servizio Alta Formazione (High level academic training services) (Piazza della Nunziata, 6-2nd floor-16124 Genova), at the page <http://www.studenti.unige.it/postlaurea/dottorati/>, within 9 october 2017.
